Risk analysis and control Risk analysis Risk and uncertainty rating identifies the importance of the sources of risk and uncertainty about the goals of the project Risk assessment is accomplished by estimating the probability of occurrence and severity of risk impact More detailed information available in the construction process can be effectively used for traditional risk management
